"Sing for joy, O heavens, and exult, O earth; break forth, O mountains, into singing! For the Lord has comforted his people, and will have compassion on his suffering ones. But Zion said, "The Lord has forsaken me, my Lord has forgotten me." Can a woman forget her nursing child, or show no compassion for the child of her womb? Even these may forget, yet I will not forget you. See, I have inscribed you on the palms of my hands!"—Isaiah 49: 13-16a

Are you getting forgetful? That was the topic of the care center services this past weekend, and when I asked those who gathered "are you getting forgetful?"... the response was all smirks and chuckling. (Of course—who isn't?) I shared with them several examples of my own chronic forgetfulness, including the story of how I once left one of our dogs at the cemetery after we had gone for a walk. (It was a happy ending—she was waiting at the same spot where I had inadvertently left her.) It has always been part of the human experience to forget things, and when you compound that tendency to forget with our increasing lifespans and the vast amounts of information that assail us on a daily basis, it is no wonder that our forgetfulness is epidemic, and an ever-present source of both amusement—and annoyance—to us.

Now in most cases our forgetfulness is not particularly consequential. If I forget something at the store, I simply go back for it, or do without it until the next shopping trip; if I forget a meeting, I apologize and move on; if I forget where I have parked, I simply wander the parking lot or activate the panic button and hope I hear the horn. But sometimes our forgetfulness can have real consequences. Summer is here again, and with it are the reports of parents who have forgotten their children in locked cars, with tragic endings. Are all such parents terrible monsters, and disgraces to parenting? In many cases, no--I don't believe so. I think many are overwhelmed, overbooked, and so harried and distracted that they even forget the unforgettable...with terrible, life-changing consequences for their children, and for them.

I selected this passage from Isaiah to remind us that even though it is our lot to be forgetful, we are assured that God has not forgotten us. God did not forget the Chosen People in Babylonian captivity, for the prophet was sent to remind them that in spite of their present circumstances they were inscribed on the palms of God's hands, and they would again know freedom and the joy of a homecoming to their promised land. And God has not forgotten us, for God sent Jesus to remind us that we are *all* Chosen People, eternally remembered and eternally loved—even when it feels as though we are forgotten by everyone else. Each miracle of feeding and healing, each word of grace and hope spoken with love by Jesus was a reminder to the "forgotten" of his day that they were always on the mind—and in the heart—of their heavenly parent. Jesus was even willing to have this Good News inscribed on the palms of his hands by roman nails, which was the terrible cost of bringing this Good News to a world ruled by those whose power rested on forgetting the needs, the rights, and the basic dignity of the majority of their fellow human beings.

Friends, the 4th of July is approaching—the anniversary when we celebrate the Founders' good news that all men (now all PEOPLE) are created equal, and endowed *by their Creator* with the right to life, liberty, and the pursuit of happiness. As more and more people are pushed to the margins by poverty, racism, xenophobia, incarceration, and lack of access to basic human necessities like affordable housing, decent employment and physical and mental health care, we who profess belief in the God who never forgets even *the least of these* should recommit to <u>that</u> Good News-- with our vote, our voice, our activism, and our generosity and devotion to just and benevolent causes. And in our day to day living we should imitate Jesus and incarnate God's steadfast, un-forgetting love as we remember those who feel completely forgotten. It can be easy to forget that there are lonely and unloved people everywhere in the world, yet it is our calling as Christians to remember them, and to offer them our love, our listening ear, our help, and the good news that they are not forgotten after all. In doing that, we will have made real the promise of the prophet, showing them that they matter...that they are loved...that they are inscribed on the palms of God's hands—and our hands.

This year, as you celebrate our nation's independence, I pray that you remember the God who always remembers you with love. And I pray that you also remember to put that steadfast love into service-- in *all* of your encounters with others! That would go a long way toward healing our fractured republic--by helping her citizens remember what makes us, or any nation, great:

Remembering ALL...and remembering LOVE. -Pastor Craig

Prison and Released Inmate Ministry: Are You Interested?

Pastor Craig has been in contact with the ministers who are in charge of Church of the Damascus Road at the Fort Dodge Correctional Facility and the support team program for inmates who are being released from FDCF. Rev. Carroll Lang and Rev. Paul Stone would welcome having people from our church worship with the inmates at their Wednesday church service or even having you participate in leading the service. You need to register ahead of time to enter the prison.

Another service project possibility is for our church to form a re-entry team of 5-10 persons to assist an inmate for a year following his/her release. The re-entry team would help the person find an apartment, pay the deposit and

first month rent, round up furniture and the like. Team members would take 6 hours of training and need to commit to a year on the re-entry team.

The Mission Board wants to determine if people in our congregation are interested in participating in a prison ministry or released inmate project. We have not committed to a project. FUNERAL POLICIES: FIRST CONGREGATIONAL UCC JUNE 15, 2016

INTRODUCTION

A funeral or memorial service is a fitting and powerful ritual that marks the ending of a human life, and such services can help those suffering from the loss of death in several ways. Funeral or memorial services bring together the bereaved, and allow the grieving community to comfort and console one another in their common loss. Funeral or memorial services help recall the life of the deceased, and promote thanksgiving for his or her life. Funeral or memorial services recall the promises of God found in scripture and faith, which bring hope and healing to all who are experiencing a loss. First Congregational UCC is committed to helping provide meaningful and consoling funeral and memorial services as a part of its mission, which is to "proclaim the Gospel, nurture and support each other, and show concern for humankind."

WHEN SOMEONE DIES

In the event of a death, the family of the deceased should contact the pastor or the church office. The pastor will visit with the family to offer condolences on behalf of the congregation and to plan a service, taking into consideration the desires of the deceased and surviving family members. Services for non-members may be held at First Congregational UCC, but only with the current pastor's consent.

FUNERAL OR MEMORIAL SERVICE?

A funeral is a service in which the body is present during the service, most generally in a casket, which may be opened or closed. A memorial is a service that is conducted without the body being present, either because the body has been cremated or has been previously interred. First Congregational UCC recommends that individuals pre-plan their funeral or memorial service in consultation with family members, a funeral director, and the pastor. There are forms in the church office to assist with the preplanning of the service, and the church will store the completed forms for future need.

Funeral or memorial services must be coordinated with the pastor's availability. The family may request a guest pastor or other speaker to participate in the service, with the consent of the current pastor of First Congregational UCC. If the family wishes to have another pastor conduct the service, they must first contact the current pastor, discuss their wishes, and secure the current pastor's consent. In the absence of the current pastor due to illness or vacation, the family may elect to hold the service upon the pastor's return, or they may choose to use the designated on-call pastor who is ministering to the congregation in the pastor's absence.

FUNERAL DIRECTOR

First Congregational UCC works closely with funeral directors in order to provide meaningful and orderly funerals and memorial services. Funeral directors have professional expertise to help plan services and burials, and they manage many of the necessary details so that families are not unduly burdened in their time of bereavement.

Members of First Congregational UCC who choose not to employ a funeral director for funerals or memorial services held in the church must meet with the pastor, who will explain what duties the family must assume in the absence of a funeral director. (see attachment #1)

Non-members of First Congregational UCC who wish to hold a funeral or memorial service in the church must first secure the consent of the current pastor, and must employ a funeral director from an established funeral home of their choice to be present for the service.

MUSIC AND AUDIOVISUALS

The final authority determining the suitability of any music and audiovisual materials for funeral or memorial services rests with the current pastor of First Congregational UCC. Instrumentalists or vocalists may be used during the service, or pre-recorded selections of music. It is the responsibility of the family or the funeral director to make arrangements for all music, and provide any pre-recorded music and audiovisual materials to the church in advance of the service.

VISITATION

Visitation prior to a funeral or memorial service may either be held at the funeral home of the family's choice or at First Congregational UCC. First Congregational UCC recommends that visitation take place on a date previous to the day of the funeral or memorial service.

RECEPTIONS AND REFRESHMENTS

First Congregational UCC is pleased to serve as the host site for gatherings in Fellowship Hall before or after a funeral or memorial service. In the event of the death of a church member, a member's spouse, or the dependent child of a member, a representative of the Women's Fellowship Funeral Committee will contact the family and explain what refreshment options the Women's Fellowship will provide. If the family wishes to have a more elaborate meal than the Women's Fellowship is willing to provide, then it is the family's responsibility to contact the caterer of their choice and make arrangements for the meal to be delivered. It is the family's responsibility to pay for the meal.

Non-members who request refreshments following the service will be served coffee, water, lemonade, and dessert bars at no charge. If the family desires a meal, then they must select a caterer and make arrangements to have the meal of their choice delivered. It is the family's responsibility to pay for the meal.

MEMORIALS

Memorials given in honor of the deceased are a meaningful way to cherish and continue the legacy of a loved one who has died. First Congregational UCC has a Memorial Committee that oversees all undesignated memorials given to the church on behalf of the deceased. The committee can offer suggestions for the use of memorial money, and they will be happy to oversee the selection and purchase of

appropriate gifts for the church. For questions about memorials, or for memorial gift suggestions, please contact a member of the Memorial Committee.

FEES

A current fee schedule for funerals and memorial services hosted by First Congregational UCC is available from the pastor or the local funeral directors. (See attachment #2)

The meeting was called to order at 7:02 pm by Moderator, Sherry Leksell. Pastor Craig opened the meeting with a devotion and prayer. Vicki moved and Tracy seconded to accept the board reports as printed. Motion carried. Treasurer, Tracy, reported income for May was \$17,761.21 and expenses were \$13,100.80. Tracy moved to put this report to audit. Holly seconded. Motion carried.

Old Business: Sherry reminded everyone that pictures for the church directory would be taken the following week. Tom moved that only members will be listed in the back of the new directory. Al seconded. Motion carried. Tracy reported that the committee to review and rewrite the constitution will have the revised constitution by the Cabinet's August meeting for a review.

New Business: Reviewed the new Funeral Guidelines booklet. Following discussion and a few changes, Tracy moved to accept. Lorraine seconded. Motion carried. On Sunday June 26th, six new members will be received into our congregation. The Cabinet will host the coffee following worship to welcome them. Sherry is responsible for the mints, nuts and ordering the cake.

Reports of Boards and Committees

Pastor's Report: Officiated at the wedding of Nick Oberender and Diana Loutsch on May 28th at Ames UCC. He officiated at the graveside service of Jack Daniels on May 21st, the funeral service for Merv Mourlam on May 26th at Foster's and the memorial service for Helen Nessa on June 1st. On May 15th the church honored our graduating seniors, presented certificated to our KLAB and Sunday School participants, and recognized our teachers and assistants. The choir is now in recess for the summer. Our Sunday morning worship service for the summer begins at 9:30 am and the first Saturday evening service will be at 5:00 pm on June 16th On June 5th London Clements was baptized during the worship service. There will be an adult baptism in our sanctuary at 3:00 on June 17th. We will take in new members on June 26th, with reception to follow. Todd Edeker will be our pulpit supply pastor on July 17th, 24th and August 28th. Our church is scheduled for the care center worship service on July 24th, but will need to reschedule as the pastor will be on vacation that Sunday. The Funeral Policy Committee has completed the draft of our funeral policy, which now needs to be approved by the Cabinet before being printed in booklet form. The Constitution Committee will meet on June 22nd. Ten attendees attended the annual KLAB lock-in on June 10-11. He reported that it was the smoothest lock-in he has attended. The children were well behaved and helpful in cleaning up. They all had a great time and great snacks. The next summer event will be on Friday, June 24th, from 4:00-6:30 pm at the church. It will conclude with a wiener roast for supper. Another summer date will be scheduled, possibly on August 23rd. The adult education class concluded on May 15th and they will begin in the fall studying the impact of social media on our individual lives, our ways of communicating and our relations with others. Pastor Craig represented the WCMA at the High School Baccalaureate service on May 18th. The Summer Lunch Program begins Monday, June 13th with First Congo taking the first week. The WCMA voted to give the proceeds of the Salvation Army bell ringing campaign (\$2285) to the Ecumenical Human Needs Fund, which has been incredibly busy disbursing funds to people in need. Sharon Perry has been working with Rhonda Masser interviewing applicants and the need has been so great that the funds have almost been completely depleted. According to our Safe Church Policy releases from nearly all minor children have been received so their pictures can be used in our newsletter and on our website. The background checks have been completed for the four adult chaperones for the KLAB lock in. The process is automated via email, takes only a few minutes to complete and results are available within a couple of hours. The cost through Praesidium is \$5 per check. The Stephen Ministry group travelled to Sweet Treats in Jewell for the first June meeting. They continue with the curriculum exploring our spiritual gifts. They continue with five matches. On CoM Pastor Craig and Joyce Gelhaus participated in a statewide day of training for the Committee on Ministry. The focus of the training was on "discernment". A Periodic Support Consultation will be conducted at First Congregational UCC of Fort Dodge on June 23rd.

Worship Board: Gretchen McGlynn, Holly Riemendschneider, Verna Bierle, Cindy Henning, Linda Lahr and Pastor Craig met in May. Gretchen has sent a letter to Sister Act requesting they come this summer if schedule allows. Holly reported that Tulips for Mothers went well, with 50 purchased @ \$ each with 6 left over. Linda will contact Todd Edeker to fill the pulpit while Pastor Craig is on vacation. Gretchen and Holly will be helping with communion on June 5th.

Communion for Pentecost was suspended this year due to many activities during worship. The pew communion for Easter went well. However, due to lack of numbers for Maundy Thursday service, next year we will gather in East Chapel for that service and at this time no Sunrise service is planned. The first Saturday service will be June 18th at 5:00 pm. A discussion was held on another pet blessing service, possibly in Sept. They will ask around for feedback from congregation. Gretchen will help with July 3rd communion and ask for another volunteer when it gets closer. There will be no meeting in June.

Mission Board: Met on May 12th. The spring clean- up around Kmart and McDonalds was done with 14 people. All the garbage bags from Fuller Hall were used, plus a few extras. First Congo will serve the summer lunch program the week of June 13th. The church is also in charge of games for this week which Lorraine will captain. Audrey is in charge of the Strengthen the Church offering for Sunday, the 15th. Beacon of Hope meal will be served on May 18th. The Relay for Life is June 16th from 6:00-9:00 pm at Twin Parks. A coffee will be served on June 5h with the pickle jar out for donations. The church collected \$150 for Special Olympics and \$240 for Ecuador relief. The ice cream social is June 15th at Faith UMC with the proceeds divided between UDMO and Ecumenical Human Needs. The group is looking for new ideas to promote our month (July) to raise items for UDMO.

Mission Board: Audrey Burtnett, Marjorie Groves, Alyssa Kenville, Lorraine McCoskey, Gayle Olson, Karin Yungclas attended the meeting. Gayle is our cabinet representative. Ginnie Veach is chairing the preparation and serving of the July Beacon of Hope meal. Our church will assist with the opening week of the summer free lunch program. Lorraine reported that 12 people are needed each day to assist with set-up of tables, sign-in, trash, clean-up, free books, etc. The helpers can work any number of days. They should come around 11:00 am to prepare for the children's arrival with the meal from 11:30-12:30.
