Wil Groves moved to approve the 2019 Annual Meeting minutes. Tracy Wehrhan seconded. The motion approved by voice vote of the congregation. Cindy Henning moved to approve the minutes of the congregational meeting held in November. Leah Maass seconded. Motion approved by voice vote of the congregation. Al Yungclas moved that each board and committee report be reviewed individually and then make one motion to approve all reports. Leah Maass seconded. Motion approved by voice vote of the congregation. A correction was made to the spelling of Livia Oberender in the Worship Board report. Cindy Henning moved to approve all board and committee reports with the correction. Kolleen Taylor seconded. Motion approved by voice vote of the congregation. Kolleen Taylor moved that each financial report be reviewed individually and then make one motion to approve all reports. Laurie Epps seconded. Motion approved by voice vote of the congregation. Discussion followed. Kolleen Taylor moved that the reports be approved with the addition of a statement to the end of the Balance Sheet that: The 300 accounts are not exact, but were accounted for in the 100 and 200 accounts. Wil Groves seconded. Motion approved by voice vote of the congregation. Donna Ryherd moved that the list of nominations for offices for 2020 be approved. Marjorie Groves seconded. Motion approved by voice vote of the congregation. Wil Groves read portions of the Annual Report from 1945 which was the oldest to be found. The next oldest was 1955 and reports are made annually after that date. Winners of the chocolate contest were named. 1st place went to Joyce Gelhaus, 2nd place to Leah Maass and 3<sup>rd</sup> place to Karin Yungclas. All contestants were thanked for their participation. Donna Ryherd thanked Nate Lahr for his leadership over the past year. Al Yungclas moved and Tracy Wehrhan seconded the adjournment of the meeting. Kolleen Taylor thanked Craig for his service to our church and community. Motion approved by voice vote of the congregation. Meeting adjourned at 12:05pm.

### THE PASTOR

Reflecting on this past year we can say with certainty that it has been a challenge! Who could have imagined that three months into the new year a pandemic would sweep through the world, our nation, and state-- even our own hometown. Who could have imagined that as of this writing over 350,000 of our citizens have died as a result of contracting Covid 19? Who could have imagined that we would have to close our church to the public-- and to its own members? And who would have guessed that this pandemic will soon reach the one year mark, with no clear end in sight? But even as 2020 has been challenging, we as a church have been resilient in our desire to continue worshipping, ministering and caring for one another! We have endured disappointments, set-backs, cancelled plans and heartbreaks big and small, and yet as we greet a new year with our church still shuttered and our members social distancing from one another we still remain committed to this particular church of Jesus Christ, and we still hear and heed his call to continue his unfinished work of bringing more light and love into our world!

We began the New Year returning from Christmas break and resuming our regularly scheduled worship services. Christian education offerings, and board and committee meetings. On Feb. 26 we began Lent with an Ash Wednesday service of worship in the sanctuary, following a KLAB spagnetti supper which netted \$435 for Christian Education activities. We conducted care center worship services on Feb. 2, our Stephen Minsters met monthly, the Shalom circle resumed for Lent, and Ashley Vaala of the Lotus Community Project was scheduled by the Mission Board to deliver a community presentation in our sanctuary on March 24. Meanwhile, there was news of a pandemic that was spreading across Asia, Europe, and making ground in the US... And then on March 17—St. Patrick's Day-- Governor Reynolds issued the emergency proclamation that essentially shut down our church for gatherings of any kind, including corporate worship! While the Cabinet was already wrestling with the decision to suspend in-person worship, the emergency proclamation marked the beginning of the many unprecedented happenings of 2020. Since no one had lived through a pandemic in over a century there was no established plan for such an emergency, which meant that new ways of ministering and continuing as a church had to be speedily developed! One big change to our common life in 2020 was in our mode of worship. Early on I decided I would not livestream worship services or make video recordings of worship services but instead make audio recordings of services using our digital recording equipment. I began creating these forms of worship services on March 29 (just in time for Holy Week!) and I have created a weekly audio recording of worship services since that date. On July 5 we held our first outdoor worship service in our vacant lot, and during the Summer and Fall months we masked and met outdoors to worship together in that beautiful setting. Our attendance at these outdoor worship services remained in the mid-30's to low 40's each Sunday, and we even managed to have "Scholarship Sunday" outdoors and hear from our scholarship recipients! While worshipping outdoors we were blessed to be able to borrow Chris McNeil's new sound system which improved the audio quality tremendously. Melissa Hindt continued to accompany us outdoors, and we added a weekly liturgist—and something new to our worship services: Don Bruner volunteered to be our song leader. We continued monthly communion using individual communion containers. We continued these worship services through

November 8<sup>th</sup> when the weather simply would not allow us to meet outdoors any longer. By this time the pandemic had really taken hold in our county and so the Cabinet voted to suspend in person worship services until further notice...including suspending all Advent services and the Christmas Eve Service.

When our shutdown began I started writing daily reflections to share with the congregation as a way to keep us connected and (hopefully) inspired. These reflections were emailed out when finished and uploaded to our church Facebook page. I composed 40 of these reflections on a daily basis, and then over time added 6 more reflections to the corpus, for a total of 46.

On Palm Sunday Vicki and I took 19 Easter gift bags created by Vicki to our KLAB and Sunday School children. Our original plan was to take them around on Easter Sunday, but by Palm Sunday there was a real possibility that the governor would order us to shelter in place, so we delivered them a week early. The Christian Ed Board voted to distribute "We Care" bags for the duration of the pandemic, and so Vicki and I have been delivering those bags on a monthly basis. Also, at the beginning of the pandemic I created personalized cards with photos of each youth to send to all of our CE students, and because we could not have our annual Promotion Sunday in May I created certificates to give out to our CE students as well.

As the pandemic progressed Vicki and I began making and delivering fudge to all active members as a way to stay connected. Also during the pandemic I have been making brownies, cookies and fudge to deliver to essential services as a way to thank them for all they are doing in these difficult times, including: First State Bank and People's Credit Union, the Webster City Police and the Hamilton County Sheriff's Dept, the Post Office, Dollar General and Dollar Tree, Yes Way, the Fire Station, Hamilton County Public Health, Kendall Young Library, and Webster City Vet Clinic (our dogs insisted on this). As we all know, to continue Board and Committee meetings in 2020 was quite a challenge. The Mission Board has met via Zoom and in-person both at Kendall Young park and in the vacant lot. Other Boards have conducted business by email, and the Evangelism Board holds the distinction of being the first board to resume meeting indoors when the Cabinet voted to reopen the church to meetings. The Christian Ed Board has met in person in our lot as well, as has the Trustees, Women's Fellowship, and Stephen Ministers.

During the summer I participated via Zoom in a week long education program called "Lemonade for Life" which helps participants understand the impact of ACEs (adverse childhood experiences) and encourages community collaboration in ways to educate, prevent, and assist those impacted by ACEs. I also participated in a multi-week study of the book White Fragility which was in collaboration with members of Jewell and Alden UCC. The study was hosted and led by Rev. Kerryn Oliver. I also conducted a book study of Raising White Kids in our vacant lot with 6 participants.

Certainly one of the most successful and novel projects of 2020 hosted by our church was the Brownie Sundae Drive-Thru event of July 24<sup>th</sup>! With the match provided by the Enhance Hamilton County food pantry challenge we altogether raised \$4,000 for our local food pantries! We also volunteered as a church to ring the bell for the Salvation Army 3 times during Advent, and our efforts alone brought in \$1906 for local ministry projects! We continued our commitment to serve the men of Beacon of Hope delicious

meals every 2 months...and we continued our Advent Alternative Gift-Giving Fair, which was very successful!

A wonderful highlight of our year was the surprise honoring of my 10<sup>th</sup> anniversary of ministry here at First Congregational! It was a delight to be honored and presented with wonderful gifts, and to have Vicki and my picture in the newspaper. Thank you! The Webster City Ministerial Association met twice by Zoom before recessing for the summer, and then we met in person once in November. Rev. Phil Webb is the new pastor at Asbury UMC; he replaces Rev. Jeff Flagg who left in late July. Rev. Mark Eichler resigned from St. Paul Lutheran, and so his duties as Treasurer of the WCMA have returned to me in addition to my duties as the chairman of the group. The WCMA voted to distribute \$6,000 of the school backpack funds and \$2000 of the WCMA General Fund to our local food pantries, and they also voted to distribute the last \$500 of the 2019 Salvation Army bellringing campaign funds to purchase grocery gift cards for the HOPES program. The Ecumenical Human Needs fund suspended activities at the beginning of the pandemic, but in August restarted taking applications for assistance via email or phone.

The wider church activities of the UCC were also affected by the pandemic this year. The UCC National Youth Event to be held in July was postponed until the summer of 2022. Our Northwest Association Annual Spring meeting was cancelled. The Iowa, Nebraska, and South Dakota Conferences of the UCC (our Tri-Conference) said goodbye in 2020 to Rev. Jonna Jensen, who left to become the interim Conference Minister of the Maine Conference until she retires. Also another of our associate conference ministers, Rev. Darrell Goodwin, left the Tri-Conference to take the position of the Executive Conference Minister of the Southern New England Conference. The Iowa, Nebraska, and South Dakota Conferences of the UCC met jointly on October 17th, 2020, for the first time ever on a completely digital platform. The UCC General Synod for 2021 has been moved to an online format so there will be no in-person gathering next year for Synod!

My work in the wider community continued in 2020, although there were challenges to serving due to Covid. I continue to be a member of Noon Kiwanis even though we suspended meeting in person for a while due to the pandemic. I still have not returned to Kiwanis, nor do I plan to until I am vaccinated. I continue to serve on the Hamilton County Crimestoppers Board as its chairman, and we meet by Zoom to conduct business. I continue to serve on the Advisory Council for North Central RSPV of Iowa, and we meet quarterly via Zoom.

While 2020 has been quite a year, we at First Congregational have remained committed to our church and are waiting in anticipation of our return to our building, our ministries and our shared life together. My prayer is that 2021 will be a year of healing, renewal, and thanksgiving for us all as we continue on as disciples of Jesus Christ and members of this church! –Pastor Craig

### **CHURCH MODERATOR**

This year as moderator hasn't been anything close to NORMAL! And I thought my biggest problem was going to be whether we joined in the RAGBRAI festivities as it passed through Webster City. 2020 was a year full of challenges. Personally, I have never experienced a year quite like it.

The church closed down in March and things were never quite the same. A letter from Conference Minister Stevens, articles from the internet and newspapers, public health recommendations, survey results along with proclamations from the Governor helped in determining how the Cabinet should proceed. It is not easy to close down in-door church services, cancel Christmas Eve services, etc. The Cabinet's top priority was always the safety of our congregation members.

On July 5th we had our first outdoor worship service in the vacant lot south of the

church. With protocols in place and some great weather, we had a nice gathering of members every Sunday. These outdoor services lasted well into the fall.

In September we made plans for the starting up of indoor church services when the weather did not warrant worshipping in the open lot. It was also decided to open the church to board meetings, circles and Stephen Ministry. New protocols were put in place but even these plans needed to be changed due to the ever-changing status of the coronavirus.

Although we have missed out on many of our beloved church activities and functions in 2020, our church family still cared for others. We made phone calls and held Zoom meetings. We sent cards. We provided food /money for the various food pantries. We joined in a parade to send Laurie Epps off to Mayo. We distributed scholarships. We provided meals to Beacon of Hope. We continued the Alternative Gift Giving Fair. We participated in ringing bells for the Salvation Army. We provided a "thank you" for our school teachers. We had a "drive-by sundae" event for the community. We passed our church budget. These are just a few of the things we continued to do.

The 2021 budget was ratified in November. Since we were not having in-person church, our challenge was to have a quorum of 40 people vote. The budget was ratified by using mail-in voting, phone calls and email. The final vote was 50 yea and 0 nay votes. Pastor Craig was a wonderful help to me during this tumultuous year. Early on in the church's closing he provided a daily reflection. Audio church services were also provided every Sunday. The 10th anniversary of having Pastor Craig and Vicki as our church leaders was celebrated with fancy cupcakes at an outdoor service. Thank you for all the work you have done for our church family this year and for making our church a driving force in the community.

Michele was easy to work with and I appreciated the fact that she made suggestions and recommendations that proved to be very helpful. Michele was very flexible when asked to take on new and different tasks during the ever changing landscape this year. She proved to be a valuable asset to me.

The end of the year is a time to reflect on the successes and challenges we've faced during the year. I want to thank all of you for participating in the surveys, the on-going church activities, those on boards/committees and for stepping up through all of our challenges. Remember that we have a lot to be thankful for. We are a wonderful and vibrant church and we add much to our community.

I will end as I have tried to end all of my church correspondence. Stay safe and make healthy decisions.

### **CHRISTIAN EDUCATION BOARD**

The year 2020 started well with KLAB attendees of 10 or so kids each week. Karinne and Vicki led the young KLABers with help from Patty Gescheidler, Susan Meinders, Wil and Craig. Ginnie Veach and Leah Maass were stalwart treat dispensers and kitchen help. Congregation members provided the treats.

The first (and as it turned out, ONLY) project was a spaghetti dinner fundraiser in Fellowship Hall February 26. Vicki and Karinne headed the effort. KLABers were the wait staff. Free will offerings netted \$435, which was earmarked to send youth delegates to the UCC National Youth event during the summer. Unfortunately the youth event was cancelled. The fundraiser turned out to be the last KLAB activity of the year.

Our after school Wednesday program was cancelled in March and has not resumed. Other planned activities—Easter breakfast, graduation, promotion and recognition Sunday, KLAB lock in, and annual trek to DQ -were all victims of Covid-19. Likewise for the beginning of the 2020-21 program year: no Rally Day, Halloween party, visits to Crestview pen pals, Christmas program, other activities. We were saddened to lose the opportunity to connect with our young people on a weekly basis.

But we kept in touch with monthly "we care" bags with treats, games and activities. Craig and Vicki spearheaded the program and made deliveries each month to 19 young people in the congregation. Most of the months had specific themes. KLABers were encouraged to do the craft or activity, then send a photo of the completed project to receive a DQ gift certificate.

### **MISSION BOARD**

In the quirky year 2020 the Mission Board continued to offer members of First Congregational UCC of Webster City dozens of ways to help others. Programs and projects were planned, then cancelled as local and state coronavirus guidelines were updated. "Flexibility" was our not-so-secret secret password. Our members were Audrey Burtnett, Marjorie Groves, Lorraine McCoskey, Gayle Olson, and Karin Yungclas, with Rev. Craig Blaufuss, as valued partner and advisor. Gayle, chair; Audrey and Lorraine, Cabinet representatives; Marjorie, secretary.

**December:** The 2019 Alternative Giving Advent Fair began with the Angel Tree and gifts bought for 10 families. For the plastic-use reduction effort, the bamboo "silverware" sold quickly. Teacher Sherry Leksell received a thank-you note from the Eagle Grove school nurse for the cold-weather gear we collected, especially for student newcomers. All pictures on the Stepping Forward Romania tree were taken, with \$675 donated. Post-confirmation students (Chesney Fuller, Brandon Lahr and Madison Babington), with Craig and Vicki Blaufuss, hosted 30-plus men at the November 19 Beacon of Hope meal. In one week, our church members donated 50 Thanksgiving "sides," such as cans of cranberry sauce, cans of sweet potatoes and pumpkin, jars of gravy and boxes of bread stuffing to the Upper Des Moines Opportunity food pantry.

**January:** Around \$2,000 was raised in the Salvation Army red kettles at Fareway and HyVee in December. \$1,630 was given to the Christmas Fund for retired clergy and church staff in the collection taken at the Christmas Eve service. Annual Meeting Souper Bowl: We collected \$372 in the Pickle Jar for the UDMO food pantry and served eight kinds of soup after the Annual Meeting January 29. Gayle took the rice, peanut butter and tuna to All Cultures Equal.

**February:** Andrea Mosbach reported serving 50-55 at the January 28 meal for Beacon of Hope, the Fort Dodge shelter for homeless men. Agape Fund: We now have \$2,764, after accepting Happy Dollars the last Sunday of the month. Lotus: The Mission Board toured the facility for homeless women and children on January 23. Founder and director Ashley Vaala gave her story, as well as shelter progress and needs.

**March:** Teacher Appreciation: Stephanie Hill, Gayle and Dale Olson, Tom and Holly Riemenschneider and Karin Yungclas served ice cream and toppings to 120 teachers and certified staff February 17 at the Middle School. Funding Future Leaders: \$339 was collected. (About here, the church building was closed because of the coronavirus.)

**April:** Zoom meeting included a guest appearance by Dale Olson of the Endowment Fund. An allocation for \$500 has been made to Funding Future Leaders. Endowment also gave \$750 each to the food pantries of ACE and UDMO, and \$250 each to Trinity and St. Paul's food pantries, along with \$500 to Lotus and \$500 to Beacon. Thanks to timely delivery of meal ingredients to the church pre- and post-lockdown, Marjorie and Wil were able to fix the recipe of Cheesy Potatoes and Ham in their home kitchen, and deliver them with bars made by church folks, along with lettuce salad and green beans curbside to the Fort Dodge shelter for homeless men.

**May:** We invited our church members to contribute four casseroles, two pans of bars, six bags of lettuce and two loaves of peanut butter sandwiches for Beacon. Pastor Craig delivered these to the Fort Dodge shelter for homeless men May 27. Pastor Craig talked with Ashley Vaala about the Lotus shelter needs. We focused on the push lawnmower.

**June:** Craig and Vicki delivered a lawnmower to Lotus on May 13. The lawnmower was purchased for \$287.83 from B&B Repair in Webster City thanks to members' donations. Sharon Perry reported that Ecumenical Human Need's work is on hold because of Covid-19 preventing face-to-face interviews. EHN was awarded \$8,000 from the Morrison Trust, a local foundation.

A Second Meeting in June: Marjorie heard Pat Powers, KQWC, interview the director of the Food Bank, who mentioned needing volunteers to make shopping bags from t-shirts. Clients can carry items from the Food Bank in the totes, rather than plastic bags. Our church delivered 42 t-shirt totes to the Food Bank in Des Moines. The Fort Dodge shelter for homeless men needed drop-off evening meals, so Gayle and Dale prepared one for them.

**July:** The Beacon was happy to get our church's July 7 meal. Discussion of *White Fragility* started July 14 with 6 in the daytime group and 6 in the evening group Zoom discussions. Our July food pantry collection netted 21 bottles of syrup and 28 boxes of pancake mix. Pastor Craig delivered about half to St. Paul Lutheran's food pantry and the rest to Trinity Lutheran's. On July 24, 6:30-8 p.m., we had our first-ever Brownie Sundae Friday. Three of us took orders and delivered them to cars, two dipped ice cream and drizzled chocolate sauce, two plated brownies, and one held the Pickle Jar for donations. We try to be humble, but the drive-thru was a huge success, making well over the traditional indoor ice cream social. We sent a \$2,000 check to the Enhance Hamilton County Foundation to be matched for local food pantries.

**August:** \$605 has been given for One Great Hour of Sharing and \$455 for Strengthen the Church. *Raising White Kids* discussion started August 26 in the vacant lot, with Pastor Craig facilitating. After the devastating derecho storm, Donna Ryherd's sister, a cook for a homeless shelter in Cedar Rapids, reported a need for bread and hotdog and hamburger buns. Our members donated quickly, and Donna took 44 loaves of bread and more than 100 buns to Cedar Rapids. **September:** Our meal for Beacon this month featured pulled pork. The Relay for Life Pickle Jar

brought in \$406 to donate to the American Cancer Society. As of the September 24 meeting, we had 62 t-shirt totes to go to ACE for use with the Food Bank of Iowa distribution.

**October:** The Mission Board's budget for 2021 is reduced to \$17,000 for one year due to the Covid-19 crisis.

**November:** Marjorie took 124 t-shirt totes to ACE to hold Food Bank of Iowa and other food pantry goods. We have delivered a grand total of 206 totes to ACE or the Food Bank of Iowa in Des Moines. Neighbors in Need: \$505 was collected for the 5-for-5 mission offering. Teacher Appreciation: Gayle recruited our church, Asbury and Trinity, along with aid from her posse of retired teacher friends, to share in collecting packets of microwave popcorn and M&Ms for the approximately 270 local staff and educators. Iowa Thank Offering: Marjorie prepared a grant proposal requesting \$2,000 funding assistance for Ecumenical Human Needs. Beacon of Hope: Pastor Craig's request to church members for turkey- or chicken-based casseroles, green beans, cranberry sauce and pumpkin bars was quickly answered for the November 20 meal. Salvation Army Bell Ringing takes place the Fridays, Saturdays and Sundays after Thanksgiving,

through December 20. Alternative Giving Advent Fair: Week 1 Angel Tree. Week 2 Stepping Forward Romania. Week 3 Lotus shelter for homeless women and children. Week 4 Almost Home, the animal shelter in Fort Dodge. We will collect The Christmas Fund to the end of December.

### SPECIAL FUNDS

Special Funds are those funds donated to the church by specific bequest, and designated for specific purposes. The funds are under the control of the Finance Board. A Special Funds Committee was created in 1988 and consists of the Chairman of the Finance Board, Special Funds Treasurer and one other person appointed by the Board. The purpose of the committee is to maximize the income from the investment of the funds and to give continuity to the administration of the funds.

**Agape** – Established to assist persons who face unusual and unexpected financial crisis. Money from this fund can be disbursed only at the recommendation of the Agape Fund Committee. The committee is composed of the Minister, Chair of Evangelism Board and Church Moderator.

**Bess Lyon Scholarship** – Awarded to high school graduates and college students for scholarships. 90% of the interest earnings are available each year. The fund consists of bonds, a note to Mayflower Home and a Money Market Account.

**Building** – Funds donated to the church for special projects and/or improvements to the church. There have been numerous donors to this fund. However, the majority of this fund came from the Rothrock and Parkhurst estates. These monies are invested in Certificates of Deposits and bonds.

**Helen Johnson** – A donation made by Helen Johnson to the church established a building fund and a scholarship fund. These were established in 2010, as directed by her will. The Building Fund was established with \$300,000 of which \$20,000 can be withdrawn each year for building maintenance. The Helen Johnson Scholarship Fund was started with \$100,000. The interest on this money will be used for scholarships to be awarded by criteria established by the Finance Board.

**Memorial Fund –** Funds donated to the church as memorials. Some contributions are undesignated and some are given for a specific purpose. Accounting for designated memorials and purchase of all items is the responsibility of the Memorial Committee.

**Poole Higher Education Scholarship –** Up to 85% of the interest income may be awarded each year to students pursuing a higher education. Preference is given to graduate students and first time applicants. The Original Bequest of \$20,000 from the Helen Poole Estate was designated to establish a scholarship fund in her name.

**Clifford Doty Memorial** – To be used for maintenance and repairs of church organ and pianos. The fund was established from the estate of long-time church organist Clifford Doty.

**Ptacek Memorial Medical Careers –** This fund was established in late 1998 with funds donated by Dr. J. L. Ptacek. Guidelines for investment of the principal and awarding of scholarships have been established by the Board of Trustees and will be administered by the Special Funds Treasurer.

**W. J. Covil –** Established in 2001 upon dissolution of the Covil Trust by the court. The money was turned over to Special Funds with interest income to be paid annually to the Endowment Fund. In 2014 the Finance Committee turned the Covil funds over to the Endowment Committee.
